The Amherst Survival Center promotes the health and well-being of residents of Franklin and Hampshire counties with a wide variety of programs designed to help people meet their basic needs. COVID has restricted some services that will likely expand in the future. Current services include:

- Free hot lunch, fresh produce, bread and a snack plus an optional sandwich for pick-up outside of the center Monday, Tuesday, Thursday and Friday 12:00 pm to 3:00 pm.
- Once per month pick-up free groceries (8-10+ day's-worth) for all family members from the food pantry. This service is restricted to residents of Amherst, Belchertown, Deerfield, Granby, Hadley, Leverett, Pelham, Shutesbury, South Deerfield South Hadley, Sunderland, Ware and Whately. There is no income cap. No citizenship requirement. No photo ID is required.
- The health clinic is free and open with limited days and hours check calendar.
 If experiencing homelessness, one can drop-in between 9:00 am and 3:00 pm
 Monday, Tuesday, Thursday and Friday to access showers, laundry, computers,
 charging stations and mail service as well as obtain socks, underwear and
 sleeping bags. Masks are required.

The Commission

On January 11, 2017, HD#1867 established the Hampshire-Franklin Commission on the Status of Women as a permanent Commission consisting of up to nine individuals to be appointed by the Massachusetts Commission on the Status of Women.

Per its enabling legislation, the Hampshire-Franklin Commission is charged with conducting an ongoing study of matters concerning women within Hampshire and Franklin counties. The Commission is mandated to report its findings to the Massachusetts Commission on the Status of Women annually and to recommend solutions to the challenges facing the women and girls of the Hampshire-Franklin area.

She has spent her career helping individuals and organizations identify their goals and optimize their talents. She served as an advocate for students with disabilities and as a volunteer Commissioner on the Conservation and Community Preservation commissions in the Town of Leverett for ten years. She joined the Hampshire Franklin Commission on the Status of Women and Girls in 2021 and currently serves as Clerk.

While attending the Stern Business School at NYU, Victoria was awarded the Management Consulting award for research on "Best Practices of Internal Management Consultants" for the Association of Internal Management Consultants. As an adjunct professor at Polytechnic University in Brooklyn, she taught an undergraduate accredited course entitled "Designing Training for the Organization," as part of the Technical Communications program of study. She is seeking an MSW so as to be able to assist individuals in a clinical practice. Victoria has several certifications including Goldratt Institute Jonah, Myers-Briggs Type Indicator Practitioner, Strong Inventory Assessment Administrator and Center for Creative Leadership's Benchmarks 360 Coach. She is a trained mediator as well as a graduate of a three-year program integrated Kabbalistic healing.
